PART 2 - BASIS OF PAYMENT (BOP)

SECTION 1 - GENERAL

1.0 Basis of Payment

The Basis of Payment is comprised of 8 Sections:

Section 1	General
Section 2	Packing and Unpacking
Section 3	Replacement Cost Protection
Section 4	SIT, Warehouse Handling and LTS
Section 5	Automobiles, Trucks and Vans of 3/4 Ton Rating or Less
Section 6	Transportation: Local Cartage and Long Haul
Section 7	Miscellaneous Charges (includes Waiting Time)
Section 8	Servicing/Certification of Articles and Appliances
Section 9	Additional Transportation Charges
Section 10	Canada/United States Cross Border

Sections 2-9 apply to moves within Canada. Section 10 applies to moves between Canada and the United States.

1.1 Conditions of Carriage

The Basis of Payment is based on the Conditions of Carriage referenced on the front and back of the Canadian Uniform Household Goods Bill of Lading and the specifications found in the Statement of Work. Refer to Part 1 Statement of Work to assist in the application of specified charges for service rendered.

1.2 Minimum Weight

Charges based on hundred weight (cwt) are subject to a 1,000 lb. minimum, including charges for packing , unpacking and local cartage.

1.3 Schedules A, B and C

Within Canada rates for Packing, Unpacking, and Warehouse Handling vary depending on where the service is provided. This is indicated by “Schedules”.

- a. **SCHEDULE A** rates apply when service is performed at any point in Labrador, Yellowknife, NT and Whitehorse, YK;
- b. **SCHEDULE B** rates apply when service is performed at any point not named in Schedule A and C;

- c. **SCHEDULE C** rates apply when service is performed at any point in the Northwest Territories and the Yukon Territory not named in Schedule A.

1.4 Breakpoints

Rates for Packing, Unpacking and Transportation also give Breakpoints which indicate the weight at which a lower charge develops by using the lowest weight and applicable rate in next higher weight bracket.

Example: Transportation Rates - Long Haul (see Section 6). A 7,200 lbs. shipment traveling 400 miles has a Transportation rate of \$68.44/cwt. Therefore, transportation charges would be: $7,200 \text{ lbs} \times \$68.44/\text{cwt} = \$4,927.68$

Since our weight is higher than the Breakpoint weight of 7,125 lbs, Transportation charges would be calculated using the lowest weight and applicable rate in the next higher weight bracket:

i.e. $8,000 \text{ lbs} \times \$60.92/\text{cwt} = \$4,873.60$

1.5 Maximum Weight Charges

- a. Canada will pay no more than the total charges for 110% of the estimated weight when the actual weight of the HG&E shipment exceeds the estimated weight by more than 10%;
- b. The 110% Rule will not apply to moves:
 - i. Originating from a third-party storage location
 - ii. To a long-term storage location
 - iii. Out of a long-term storage location

1.6 Payments

All moves must be invoiced in Canadian Dollars (CAD) and will be paid in Canadian Dollars (CAD).

1.7 Invoice Adjustments

During the audit process of invoices, TAs may detect errors or omissions and will adjust the invoice accordingly. The TA will inform the Contractor of any invoice adjustment by sending a revised invoice by fax. Invoice adjustments will be made as described below for the following situations:

- a. When non-admissible items are carried: adjustment of weight and charges.
- b. When limited items are carried and limits are exceeded: adjustment of weight and charges.
- c. When non-admissible services are invoiced: adjustment of charges.
- d. When SIT or LTS is in an unauthorized warehouse: storage charges (warehouse handling in/out and daily storage) shall not be paid.
- e. When payments for liquidated damages or service shortfalls are deemed outstanding, IDC departmental authority reserves the right to authorize TA to make invoice adjustments.

SECTION 2 - PACKING AND UNPACKING

2.1 General

- a. Packing/Unpacking rates include crating/uncrating. Crating/uncrating shall be provided to the shipper when it is deemed necessary by the Contractor. When a shipper elects to have an item crated that the Contractor would not normally crate, it will be done at the shipper's expense (to be invoiced to the shipper).
- b. Hourly cartage rates for local moves include packing and unpacking.
- c. Invoices for Unpacking must be supported by a signed unpacking certificate.
- d. Unpacking shall not be performed by the Contractor or his agent when specifically directed by the shipper not to perform the unpacking service.

SECTION 3 – REPLACEMENT COST PROTECTION (RCP)

3.1 HG&E Replacement Cost Protection (RCP) and PMV Protection Coverage (PC)

- Liability for loss or damage to the HG&E and/or the PMV is the responsibility of the Contractor. Terms of the coverage will be as per Annex A – Statement of Work of this contract. The 110% will not apply. Coverage includes all phases of the move, unless specified, including SIT and SIV and associated handling.
- RCP rate will be expressed as a flat rate for \$120,000.00 of coverage, regardless of the weight of the shipment.
- RCP over and above the \$120,000.00 will be expressed as a rate per \$1,000.00.
- PC rate will be expressed as a rate per \$1,000.00 valuation.

SECTION 4 - SIT, SIV, WAREHOUSE HANDLING and LTS

4.1 Storage In Transit (SIT)

- a. For a period up to 30 days commencing the day following the last day of the minimum TTG, as per Part 1, SOW, annex B, excluding the storage of automobiles covered at sub-para (c)

\$0.29 per cwt/day
- b. When an automobile, truck or van of ¾ ton rating or less requires storage, a fee of **\$8.19 per vehicle** for each 24-hour period or fraction thereof including weekends and holidays, shall be included for the handling and storage. This fee is subject to a **minimum of \$43.08 per vehicle**.
- c. Monthly rate (or fraction thereof) for storage in NWT, NU and YK

\$10.65 per cwt

4.2 Storage In Van (SIV)

- a. a. SIV (includes storage and cartage)

\$2.00 per cwt/day
- b. If an SIV move must be converted to SIT, then the SIT charges begin when SIT is authorized. No SIV will be paid on the day of transfer to SIT.

4.3 Warehouse Handling and Delivery Out Charges

- a. SIT/LTS
 - i. SCHEDULE A Warehouse Handling IN **\$6.99 per cwt**
Warehouse Handling OUT **\$3.42 per cwt**
 - ii. SCHEDULE B -Warehouse Handling IN **\$6.87 per cwt**
Warehouse Handling OUT **\$3.42 per cwt**

- iii. SCHEDULE C – Warehouse Handling IN **\$7.81 per cwt**
 - Warehouse Handling OUT **\$6.38 per cwt**
 - b. Delivery Out
 - i. SCHEDULE A **\$26.29 per cwt**
 - i. SCHEDULE B **\$23.44 per cwt**
 - c. Minimum SIT Delivery Out Charge **\$788.00**
 - d. Northern Rates for the Northwest Territories and the Yukon Territory

All shipments that require cartage, change of modes, land to air or sea, delivery from SIT, delivery from SIV, cartage to or from LTS, will be subject to the following schedule:

4.4 Long Term Storage Rates

- a. Monthly storage rates will depend on the location of the warehouse, as per the rates listed below:
 - i. SCHEDULE A - **\$5.45 cwt/month**
 - ii. SCHEDULE B - **\$4.87 cwt/month**
 - iii. SCHEDULE C - **\$10.65 cwt/month**
- b. Regardless of when the lot went into storage, storage payment will cease either on the removal date specified or the actual date of removal, whichever is the earliest.
- c. See Part 2, BOP, Section 1, paragraph 1.5,e for LTS invoicing procedures.

SECTION 5 - AUTOMOBILES, TRUCKS AND VANS OF 3/4 TON RATING OR LESS

See SIT section for auto Storage.

When an automobile, truck or van is transported within the van body, the following flat rate charge will be paid:

SECTION 6 - TRANSPORTATION: LOCAL CARTAGE AND LONG HAUL

6.1 Application

Rates in this section apply to within Canada shipments only.

6.2 Minimums

Rates are subject to a 1,000 lb minimum EXCEPT for Consolidated shipments from single quarters on Canadian Forces units (Part 1 SOW, Annex A, Rule 19). These shipments are considered to be moved from a single address therefore calculation will be based on the total weight of all of these shipments.

6.3 Rates Include

Rates include the disassembling of set-up pieces of furniture at their location in the establishment of owner, the physical handling from such location to the van, stowage of same within the van body, unloading of goods at destination, handling of same to place in establishment designated, and the reassembling of furniture disassembled at origin.

6.4 Over 50 Miles

Long Haul rates will apply for all shipments over 50 miles, with origin and destination within Canada and Territories.

6.5 Fuel Surcharge

The initial fuel surcharge for this tariff will be set at 1% of transportation charges indicated in item 6.7 following. Additional increments will be added based upon the following structure:

6.6 Local Cartage

- a. In situations where there are no agents within a 50 mile radius of the original local move, a surcharge consisting of the Treasury Board mileage rate for the Province or Territory will apply for mileage in excess of 50 miles. Subject to TA's approval, necessary meals and hotel expenses supported by receipts may be reimbursed at Treasury Board rates.
- b. Hundredweight (cwt) rates shall normally be used for local cartage, however, hourly rates may be used at the discretion of the TA if it is considered more feasible, i.e., it is impractical to weigh the shipment.

- d. Hourly Rates
These local cartage rates include packing, unpacking and replacement cost protection.
 - i. Vehicle and one person **\$226.12 per hour**
 - ii. Each additional person **\$76.74 per hour**
- e. Northern Rates for the Northwest Territories and the Yukon Territory
 - i. Vehicle and one person **\$219.80 per hour**
 - ii. Each additional person **\$74.80 per hour**
(applies to hourly rates for remote shipments). Time is based on when leaving to the airport, air travel time, and travel to residence at origin, or commencement of service.

6.7 Long Haul Rates

a. Excess Mileage Line Haul Rate:

The rates in the following table apply to moves of 51 miles or more. When shipment distance exceeds 4,800 miles, take the 4,800 miles transportation rate for the appropriate weight and add **\$2.31** for each additional 100 miles, or fraction thereof, to arrive at the transportation rate to apply.

b. Small Shipment SC applies to shipments under 4000 lbs:

i. Minimum Pick-up Charge (up to 4,000 pounds)	\$525.00
ii. Minimum Delivery Charge (up to 4,000 pounds)	\$263.00

c. Empty Mileage:

Empty mileage will be paid at a rate of **\$2.63** per mile for each mile in excess of 100 miles, determined from the distance between the point of the nearest agent's warehouse to the point of origin residence. (Empty Miles for NT, YK and NU – see Ferriage and Surcharges)

6.8 Long Haul Rates

Loading and unloading of third-party trailers – Load and unload of trailers will be paid at a rate of \$17.86 per cwt for loading and \$13.66 per cwt for unloading.

SECTION 7 - MISCELLANEOUS CHARGES

7.1 Application

These charges are applied on an as required basis and **will only be paid when pre-approved and service delivery is verified by Atlas.**

7.2 Incentive for Rush Moves

For all rush moves, a price premium of 15% of transportation costs plus pack/unpack costs is applicable.

7.3 Shuttle Services

Shuttle service may be authorized when a unit cannot get close to the residence and a smaller truck is required to bring the goods to or from the residence. Long carry does not qualify for shuttle service as it is covered in transportation. Shuttle service charges are inclusive of vehicle and all required labour:

7.5 Access to PMQ Attics at CFB Borden and Kingston

A flat rate of \$523.10 will apply in all cases where a member in a PMQ in Borden or Kingston requests access to/from an attic for the purpose of removing or placing of furniture and effects. In order to invoice for this fee, the Contractor must first receive written certification from the member that goods were added to or removed from the attic. This certification may be annotated on the packing/unpacking form or any other suitable document and shall be submitted with the invoice.

7.6 Waiting Time (Not the fault of the Contractor)

Waiting time will be paid in accordance with the terms as follows:

(1.5 hours of free time will be included in the transportation rates and is mandatory. Waiting starts when the vehicle arrives at residence)

7.7 Scaling

Scaling, when applicable, will be paid as a flow-through cost. The Contractor must supply the weigh scale invoice as part of their invoice package. Scaling will not be paid if the weigh scale invoice is not provided.

SECTION 8 – SERVICING/CERTIFICATION OF ARTICLES AND APPLIANCES

8.1 Flat Rates

A one-time, flat rate of **\$215.00** will be invoiced for the servicing and certification of articles and appliances/major electronic items at origin and the servicing of appliances at destination. This charge shall be shown on the same invoice as the packing charges. If no servicing/certification, no fee is payable.

8.2 LTS

Should the shipment go into LTS there will be no additional servicing charge invoiced upon delivery from the warehouse, with the exception of those lots described in para 2.3 below.

SECTION 9 – ADDITIONAL TRANSPORTATION CHARGES

9.1 Ferriage & Surcharges

This section includes transportation surcharges and ferriage. For all other rates see the applicable section in the BOP. Ferriage and surcharges are in dollars and cents per hundred pounds and shall apply where appropriate on the total actual weight of the shipment, subject to 1,000 pounds minimum EXCEPT where otherwise indicated. The weight of an automobile is only included when it is shipped on the same move order as the household goods AND either the origin or destination is in a location identified in Schedule A.

The surcharges in this section, other than those for ferriage, are to compensate moving van operators driving over rough roads and/or driving in remote areas where there is little chance of additional moves. SECTION 10 - CANADA / UNITED STATES CROSS BORDER

10.1 Pricing

All moves will be distributed at current Atlas 1000 rates subject to a 65% BLD discounted rate. SIT and SIV rates will be distributed based upon rates identified in Section 4, in Canadian funds.

10.2 Re-pack after Customs Inspection

When directed by a Customs representative to make a shipment available for inspection, thus necessitating re-packing after the inspection, the following rates will apply to cover outstanding expenditures by the Contractor.

The Contractor shall present supporting documentation detailing the type of inspection performed (partial or full). The documentation must be an original Customs Inspection Certificate or recognized stamped Customs document that describes the type of inspection conducted. Full inspection will be compensated based on weight of shipment based upon the following rate expressed in Canadian Funds: **Re-Pack \$33.01 per cwt**

10.3 Services to/from Alaska

Origin Services (all inclusive rate expressed in Canadian funds): **\$79.21 per cwt**

Destination Services (paid in Canadian funds):
